10 – ENTRIES

The 2 Hour 45 Minute American Le Mans at Mid-Ohio race is an invitational event in that cars conforming to the 2001 Le Mans (ACO) LMP and GT categories' technical regulations are invited to enter.

- The number of entries that may be submitted by an Entrant within any category or class is free.
- Entry Deadline – Entry forms must be received by the Organizer by **midnight August 8, 2001**.
- A maximum of (40) entries will be selected from those entries received by the deadline.
- Invitations – “**Invitations**” to participate will be sent to the Entrants of all Entries accepted by the Selection Committee by the close of business on Thursday, August 9, 2001.
- Refusal of Entry – The Selection Committee may refuse an entry without having to specify the reasons.
- Official Entry – An entry form becomes officially an “**Entry**” when the Organizer sends the “**Invitation**” to participate to the Entrant.
- Transfer of an Invitation is not permitted. The Organizer will cancel an Invitation should an Entrant be unable to honor it.
- Confirmation – The Entrant shall confirm his/her participation after receipt of the **Official Invitation** by Friday, August 10, 2001 at the latest.
- Withdrawal – Withdrawal of an entry is irrevocable once Organizer has sent invitation to Entrant.
- Neither the Category nor the Class of a selected car may be changed. Change of the specifications of a car is only permitted with the Organizer's agreement.

11 – ORGANIZATION

The American Le Mans Series is run under license from the Automobile Club de l'Ouest (ACO) by the American Le Mans Series, LLC and is sanctioned by Professional Sports Car Racing, Inc.

The sanctioning organization (Organizer), Professional Sports Car Racing, Inc. (SPORTS CAR), is responsible for the sporting regulations, the organization of the race itself and the technical rulings.

12 – ENTRANT'S DECLARATION

I (Name/Team) _____ the undersigned Entrant:

1. Undertake on behalf of my drivers and crew, to abide by the rules forbidding the use of drugs and agree to the possible testing by the official doctors.
2. State that I have read and understand the International Sporting Code and its regulations (races on circuits), the SPORTS CAR Code, the Automobile Club de l'Ouest Specifications "2001" and the Supplementary Regulations for this Event, and that I will abide by the decisions of the Officials nominated by Professional Sports Car Racing, Inc. (SPORTS CAR).
3. Further understands that an entry is considered official when SPORTS CAR receives the entry form(s) with payment before the entry closing date and SPORTS CAR confirms the entry in writing. Any entry submitted and accepted constitutes a contract binding the Entrant to take part in the event either with the drivers designated or with SPORTS CAR approved substitute drivers. In submitting this entry, the Entrant verifies that he/she agrees to abide by the SPORTS CAR Code and that the race car being entered and described in the entry forms complies with the SPORTS CAR Code and amendments thereto.

The signature of the Entrant grants permission for the American Le Mans Series, series sponsors, event promoters and SPORTS CAR free of any charges, duties or fees to use, reproduce, have reproduced, show, have shown, without limitation in space or time, all soundtracks, photographs, drawings, trademarks, films/video pictures concerning competitors, their drivers, teams or cars involved in the race on any medium whatsoever for any documents, reports, coverage, broadcast, program, publication, software, etc. whether past, present or future. The organizer may freely assign its rights to a third party.
